Quarterly Meeting with First Business Bank: The foundation is a stock portfolio and is doing very well. Friends of the LaValle Public Library joined the foundation.

5. Discussion:

- a. Cornerstone Awards: take a year off for smaller awards or main award?
 - i. Kristi's idea of transforming to a Sat continental breakfast at a library lower cost but more work since libraries don't have catering or set up and clean up.
 - ii. Donors give on an annual basis with or without Cornerstone award most don't attend event.
 - iii. If people give because of Cornerstone recipient they only do it for one year
 - iv. Interest in smaller awards has waned. Very few nominations. Has not increased attendance in a sustainable way. Has not increased donations.
 Several ideas were discussed:

Do a virtual fund raiser online.

Provide "table tents" at local restaurants in each county noting 10% of every bill will go to the SCLS Foundation. It may also be beneficial to find a restaurant in the towns of the libraries in the foundation. Because the foundation may be difficult to describe, it was suggested that examples of what the foundation would like to purchase for the member libraries so patrons know what they are paying toward. It was noted that the Cornerstone event is the only visibility of the foundation. Some fear that if the event is dropped, it will lose visibility and may be difficult to start again.

Do the librarians appreciate receiving the awards? There doesn't seem to be any interest in the libraries submitting nominations for the awards.

Could the mailings be more "exciting"? Look at a different way to promote the Foundation. Ask Brava or Madison Magazine to do a feature article? Are there other local promotional outlets? Human interest story? Include an article about the digitized items that are available because of the Foundation's support. Get first hand testimonial. Interview someone from Historical Society about how important digitized items are.

The Board decided that the Foundation Cornerstone mailing will continue for 2020, but the Cornerstone event and smaller awards will be put on hold for a year. The board will further discuss the restaurant "table tent" idea in January.

The Foundation website will be moved to Drupal this Friday!
