M. Furgal seconded. Is there a liability issue with the cooking maker kits that could reflect on the foundation because it was purchased with its funds? The presenters would be using these items for demonstrations to provide opportunities to libraries that don't have kitchens or a place to store; not patrons. There will be protocols to follow for sanitation.

- a. Disbursement of 2020 funds \$ 3,795.73.
 - i. Ripple Training with August Ball at 2020 November All Directors Meeting \$1,678. The foundation board approved this amount.
 - ii. The foundation board approved \$1,517.73 toward Advantage materials. Any funds that are not spent on the cooking/baking maker kits will be added to the amount for Advantage purchases.
 - iii. Maker Kits: The foundation board approved up to \$600 total for two maker kits; one cooking and one baking.
 - iv. Advantage materials donations approval to spend as soon as it is received.
- b. New Fundraising; restaurants with SCLSF nights for support T. Walske discussed the possibility of gift cards through Food Fight and a percentage of sales would benefit the foundation. The only catch is that the cards have to be bought within a specific timeframe. It's worth discussing as a way to partner with community restaurants. This topic will be discussed further at the July meeting.
